JUNIOR MEMBERSHIP AND LICENSE BENEFITS

USA Cycling has made memberships for all riders with a racing age of 18 and under free. This membership includes a free racing license and offers the following benefits:

- Entry into USA Cycling sanctioned MTB, Road, Cyclocross and Track races
- A domestic junior race license valid for any earned race category
- Tracking of results and ranking for USA Cycling and select affiliate races
- Member benefits at many gravel races, gran fondos and fun rides
- Industry benefits and discounts

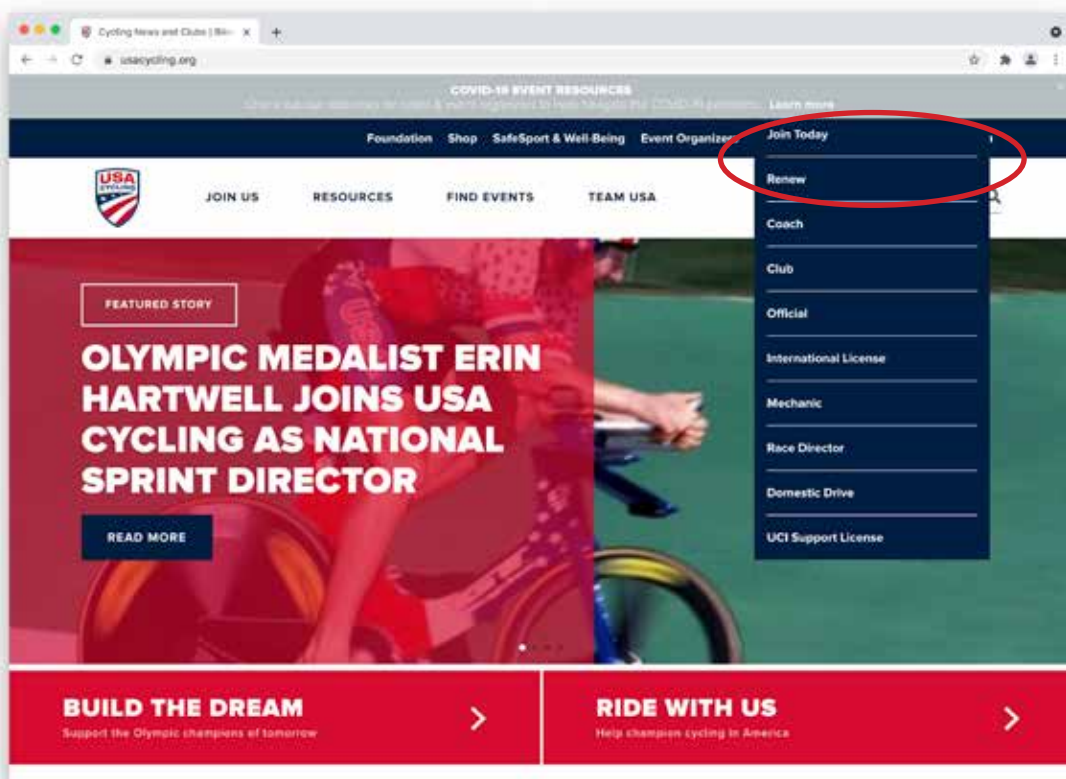
Once you have created a membership and license using the steps indicated below, you can manage your account by using the e-mail and login credentials shown in these steps.

Your License Number, also know as a Comp ID or Member Number, should be written down as it allows USA Cycling, event staff and officials to more easily look up your account.

Also be sure and download the free USA Cycling app for Android and Apple devices. The app will provide an e-license, and allow you to track your results and look for local events. The login for the app is the same as what you will create below on the website.

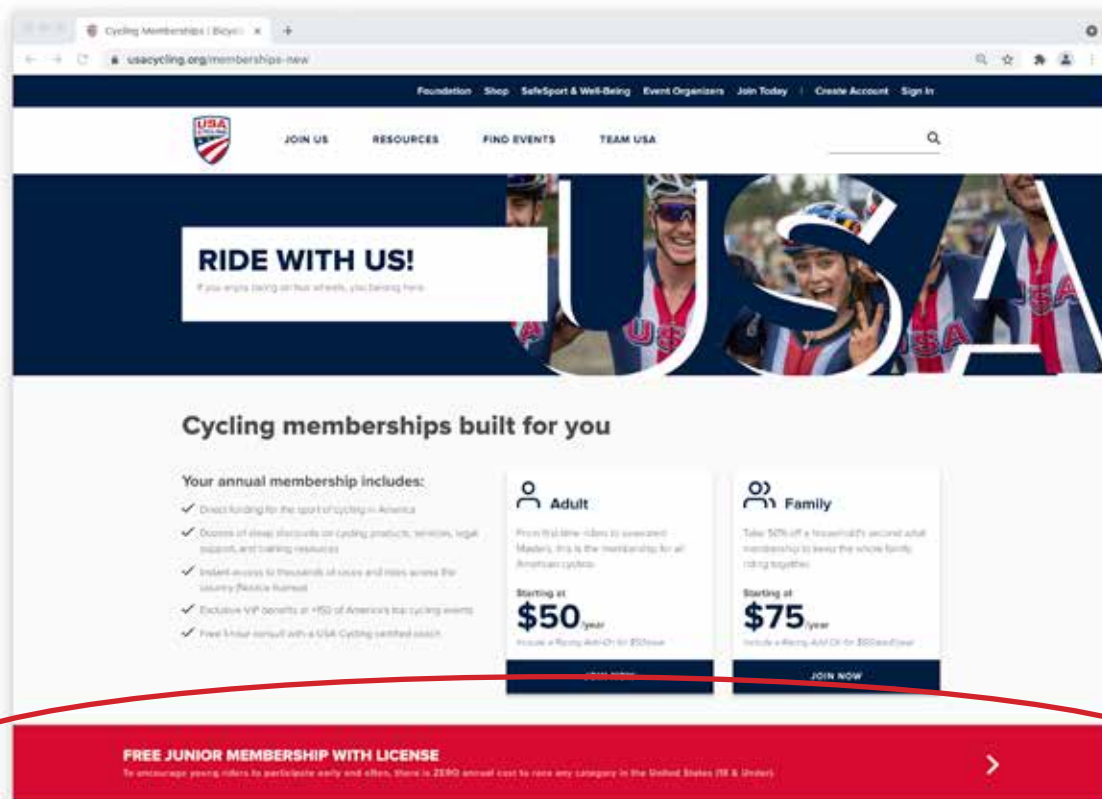
HOW TO FAQ

1. Go to www.usacycling.org and choose “Join Today” from the blue bar on top of the main page. Renewing members may log in or choose “Renew” to skip some steps.

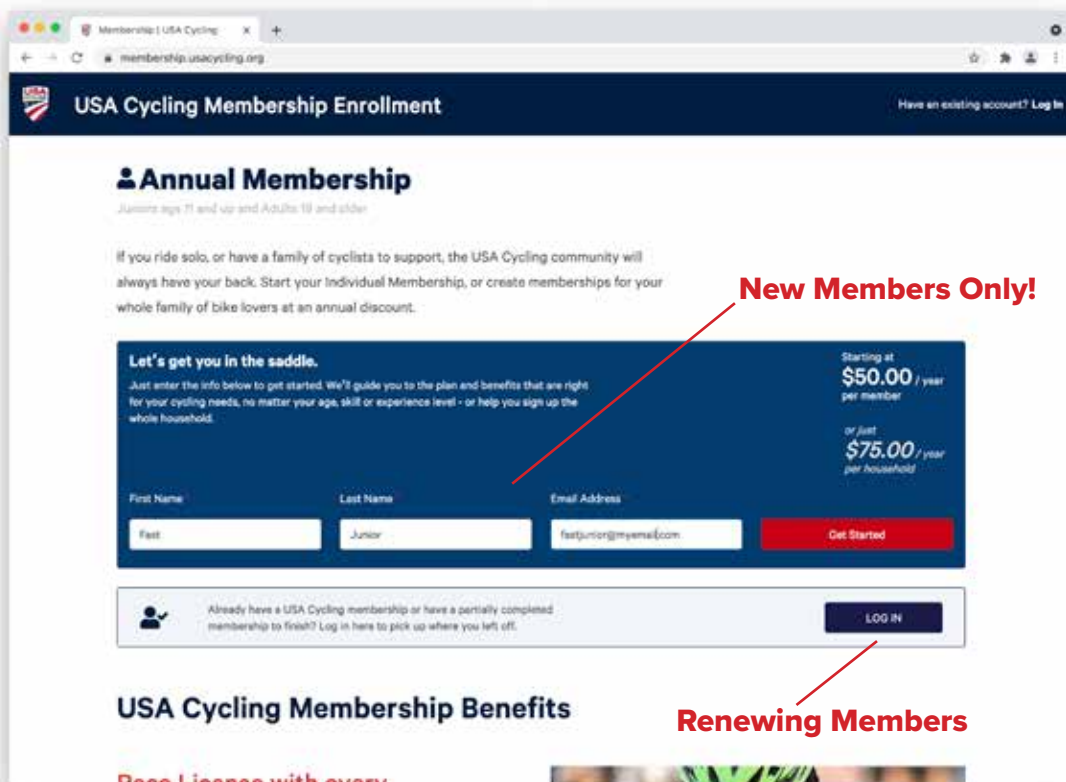




2. Clicking “Join Today” will take you to the memberships page - here you will want to click on the red bar for Junior Memberships. Renewing members may get a pop up to enter login credentials, doing so will pre-enter information and allow you to skip steps.



3. Click the Junior Membership link will take you to this page, where you will enter our name and e-mail to begin creating your account. Existing members are again presented with the option to log in - do not enter your name and e-mail here but rather use the blue “Log In” button. Failure to do so will result in a new account without all of your categories, race history, etc.





4. Fill out all of the relevant information for the member here, including password information that will be used with your e-mail to log in at a later time. Note that International Licenses do carry a cost, even for Juniors. See the information at the end of this document for more info.

I agree to rule and participate to neither endanger myself nor others; accept responsibility for the condition and adequacy of my equipment and any equipment provided by others for my use. I will wear a helmet that complies with USAC rules and regulations, and I assume all responsibility for the selection of such a helmet.

5. Anti-doping: I understand and agree that the UCI Anti-Doping Rules and U.S. Anti-Doping Agency (USADA) Protocol apply to me. I agree to submit to drug testing if it is determined I may have committed an anti-doping rule violation. I agree to submit to the results management authority and processes of USADA or the results management authority of the UCI and my national federation. I agree that arbitration is my exclusive remedy under the above rules.

7. Use of Information: I understand that USAC may collect or receive my contact information in connection with this agreement, and use it to administer this agreement and for marketing purposes. I further acknowledge, agree and consent that (a) USAC and its designees may share this information with third parties who need access to this information to perform services on USAC's behalf, (b) USAC may also share this information with select marketing partners, and (c) USAC and its select marketing partners may use this information to contact me with information and offers believed to be of interest to me.

8. Media Grant: I irrevocably grant and license to USAC and its affiliates, the right to capture and use my image, likeness, name, voice, comments or other proprietary or public rights in any broadcast, telecast, photograph, video, or audio sound recording taken in connection with an Event, without compensation, for all purposes, including any commercial use so long as such use does not imply my endorsement of any company, product or service.

9. Governing Law, Jurisdiction, Severability: This agreement shall be governed by and construed under the laws of Colorado, without regard to its choice of law rules. Any legal suit, action, or proceeding arising out of or relating to this agreement shall be instituted in the federal court located in Denver, Colorado, or state courts located in Colorado Springs and El Paso County. Each party irrevocably submits to the exclusive jurisdiction of such courts in any such suit, action or proceeding. If any provision of this agreement is invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability shall not affect any other provision of this agreement or invalidate or render unenforceable any other provision in any other jurisdiction.

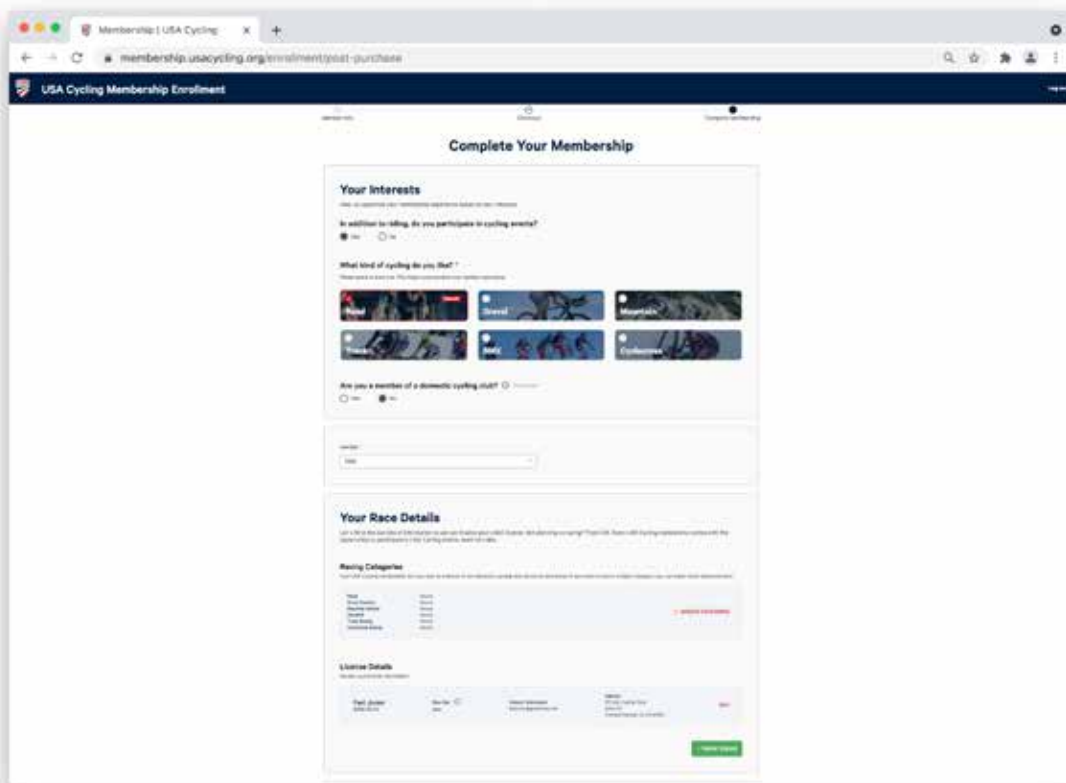

MEMBERSHIP AND LICENSE FAQ

How long is my membership and license valid for?

The free domestic licenses are good for 365 days from the day of purchase. Due to international regulations, International licenses expire on December 31 of each year.

Where can I use my license?

Your Junior license may be used in USA Cycling sanctioned event across all disciplines, and allows you to race in any earned category. Using your member number also allows you to accumulate ranking points in certain interscholastic races that have an agreement with USA Cycling.

What is an international license?

International licenses are required to race outside of the United States as well as in UCI International events within the US. These licenses carry additional required insurance and require verification with USA Cycling and are offered at a discount for Juniors.

What is a UCI ID?

A UCI is a unique identifier required to compete in events such as Nationals. Assignment of the UCI ID is free, but requires verification. See this [FAQ](#) for more information.
